



## PRODUCT SPECIFIC LICENSE TERMS

### Sybase® Unwired Platform v1.2.x (all editions, all platforms) ("Program")

IN ADDITION TO THE LICENSE TERMS SET OUT IN THE SYBASE LICENSE AGREEMENT, THE FOLLOWING ADDITIONAL OR DIFFERENT RIGHTS AND ACCOMPANYING OBLIGATIONS AND RESTRICTIONS SHALL APPLY TO THE PROGRAM FOR WHICH YOU HAVE PURCHASED A LICENSE.

The Program may contain or be provided with component software products from both Sybase and third parties. Except as set forth below, use of all components is limited to use in the same manner and capacity for which the Program as a whole is licensed. Additional licenses for Sybase components may be available from Sybase for a fee.

#### I. Definitions

Notwithstanding any language in the Agreement or Exhibit A to the contrary, for purposes of calculating the fees owed for CPU License(s) of the Program, the number of CPUs is equal to the number of Processors or Cores on a Machine.

#### II. Limitations on Use of the Program.

**A. Personal Developer Edition.** The Personal Developer Edition of the Program is licensed for internal development and testing purposes only. The Personal Developer Edition is limited to use by single Standalone Seat with a connection limit of five (5) mobile devices. Deployment licenses for any purpose (including, without limitation, usage in a general production environment or on a web server) must be purchased from Sybase before you deploy any production components contained in the Program.

**B. Enterprise Developer Edition.** The Enterprise Developer Edition of the Program is licensed for internal development and testing purposes only. The Enterprise Developer Edition is limited to use by a single Standalone Seat with a connection limit of twenty (20) mobile devices. Deployment licenses for any purpose (including, without limitation, usage in a general production environment or on a web server) must be purchased from Sybase before you deploy any production components contained in the Program.

**C. Enterprise Edition.** The Enterprise Edition of the Program is licensed for use on a per Core basis with connection to Class A or Class B mobile devices, as applicable. The Enterprise Edition license is based on (i) the number of Cores on which the Program is used, and (ii) the number of mobile devices to which the Program is connected. If you purchase a license for the Enterprise Edition of the Program, you may use an unlimited number of mobile applications on each mobile device for which you are licensed.

**Terms Applicable to Enterprise Edition – Single Application Client.** The Enterprise Edition - Single Application Client is a limited use license which may be purchased in conjunction with an Enterprise Edition - Server license. If you purchase a license for the Enterprise Edition – Single Application Client, you may only use one (1) mobile application on each mobile device for which you are licensed. If you wish to use more than one (1) mobile application per mobile device, you must purchase (i) additional licenses for the Enterprise Edition – Single Application Client, or (ii) upgrade to a full-use license for the Enterprise Edition of the Program.

**D. Annual Subscription Edition.** Notwithstanding any terms to the contrary in the Sybase License Agreement, the subscription edition allows for deployment of the Program during a twelve (12) month license term. You must renew your annual subscription for the Program prior to any use of the Program beyond the twelve (12) month subscription term. There are three (3) license groups for the subscription edition as identified below. Each of the three (3) license groups is available for use with one of two classes of mobile devices: Class A includes Smartphones; and Class B includes laptop workstations, mini/sub-PCs and tablet PCs.

**i. Starter Package\*.** A Starter Package license for the Program is limited to use by a single Machine with a maximum connection limit of twenty-five (25) Class A or Class B mobile devices, as applicable. The annual subscription-based license is made available for a flat fee.

**ii. Advanced Package\*.** An Advanced Package license for the Program may be used by a single Machine with a connection to twenty-six (26) to one hundred (100) Class A or Class B mobile devices, as applicable. The annual subscription-based license is made available for a flat fee.

**iii. Enterprise Package.** The Enterprise Package for the Program is licensed on a per Core basis with connection to Class A or Class B mobile devices, as applicable. The annual subscription-based license is based on (i) the number of Cores on which the Program is used, and (ii) the number of mobile devices to which the Program is connected. If you purchase a license for the Enterprise Package, you may use an unlimited number of mobile applications on each mobile device for which you are licensed.

**Terms Applicable to Enterprise Package – Single Application Client.** The Enterprise Package - Single Application Client is a limited use license which may be purchased in conjunction with an Enterprise Package - Server license. If you purchase a subscription license for the Enterprise Package – Single Application Client, you may only use one (1) mobile application on each mobile device for which you are licensed. If you wish to use more than one (1) mobile application per mobile device, you must purchase (i) additional subscription licenses for the Enterprise Package – Single Application Client, or (ii) upgrade to a full-use subscription license for the Enterprise Package.

\* You may not purchase multiple starter package or advanced package licenses for use on a single Machine. Instead, you must purchase a single package license which reflects the total number of mobile device connections to be made by the licensed Machine.

**III. Restricted Use Components.** The Program contains or is provided with the Restricted Use Components identified below. You may Use the Restricted Use Components solely in conjunction with your use of the Program, and subject to any Additional Restrictions set forth below.

**IV. Use of Afaria Enterprise Server and Afaria Session Manager (“Afaria Components”).** A Program Seat license must be purchased for each mobile device that accesses the Program. You may not purchase Program CPU licenses only and use the Program in conjunction with mobile devices using separately purchased licenses for the Afaria Components.

**V. Free Download Components.** The Program, including any Developer Components and Restricted Use Components provided with it, may include certain third party open source and other free download components (“Free Download Components”). You may have additional rights in the Free Download Components that are provided by the third party licensors of those components. The Free Download Components and any such third party licenses and third party-required notices for the Program are identified at <http://www.sybase.com/thirdpartylegal> (third party licenses and notices for Free Download Components included as part of the Developer Components and Restricted Use Components are identified under the names of those products). Any obligations undertaken by Sybase in the Agreement relating to the Free Download Components as part of the Program are provided by Sybase alone, and not by the third party licensors of the Free Download Components. **A. FURTHER DISCLAIMER OF WARRANTIES AND LIABILITIES.** The Free Download Components are provided “AS IS” by the third party licensors, who disclaim all liabilities, damages (even if they have been advised of the possibility of such damages), warranties, indemnities and other obligations of any kind, express or implied, with regard to the Free Download Components. Nothing in the foregoing affects any performance warranty provided by Sybase with regard to the Program as a whole. **B.
